# ON APPROVAL OF THE SECOND NATIONAL ACTION PLAN OF THE REPUBLIC OF ARMENIA FOR 2022-2024

# OF UNITED NATIONS SECURITY COUNCIL RESOLUTION 1325 ON WOMEN, PEACE AND SECURITY AND ITS IMPLEMENTATION SCHEDULE

Guided by Article 146 of the Constitution of the Republic of Armenia, the 13th point of the section "Ministry of Foreign Affairs" of the "Action Plan of the Government of the Republic of Armenia for 2021-2026" approved by Annex 1 to the Decision N 1902-L of November 18, 2021

The Government of the Republic of Armenia decides:

- 1. To approve the Second National Action Plan of the Republic of Armenia for 2022-2024 of UN Security Council Resolution 1325 on Women, Peace and Security and its implementation schedule in accordance with the Annex.
- 2. This decision enters into force on the day following its publication.

#### Introduction

The Republic of Armenia developed National Acton Plan (hereinafter Plan) on UN Security Council Resolution 1325, thus reaffirming its willingness to continue the work towards the themes on women, peace and security. The plan is based on the previous National Action Plan analysis and takes into consideration the achievements and lessons learnt. The Plan refers to the issues and challenges emerged for the women and girls displaced in the result of the war of aggression unleashed by Azerbaijan against Artsakh in autumn 2020, as well as for the women and girls of the border regions of Armenia. As a result of the war of aggression, 80 civilians were killed, 12 of which were women, meanwhile the majority of them were older persons.

As a result of the war of aggression more than 91.000 persons were forcibly displaced and provided with shelter in Armenia, 88 percent of them were women and children. The use of force had its negative impact on regional stability and the lives and health of hundreds of thousands of people were jeopardized.

The war of aggression has unleashed and continued in the conditions of COVID-19 pandemic, thus complicating making the situation of women and girls.

Thus, the Plan represents the problems of women and girls appeared in a critical situation, referring to their security component. The Plan specifies the issues of forcibly displaced women, emerged security-related challenges as a result of the new border situation and their impact on women and girls. The Plan emphasizes the importance of women's participation in the defense system, underlines the necessity of involving local self-government bodies in order to ensure the effective implementation of the provisions of the Plan at the local level.

The Plan covers a timeline of three years, and, being a living document, has the opportunity to be revised and amended, to reflect the current situation.

The Plan has been designed based on the principle of inclusive participation, particularly, in the process of its development in addition to state institutions there were involved representatives of non-governmental organizations and women affected by the war, including those who were displaced from Artsakh.

The Plan reaffirms the necessity of cooperation among various institutions inside the country, as well as of international cooperation.

Thus, based on the main pillars of 1325 - participation, protection, prevention, recovery and relief: new separate direction – cooperation - is being added to the 2022 - 2024 NAP. The Plan defines a new strategy of monitoring and proposes a mechanism which can best assess the effectiveness of its implementation.

The Plan is in line with other strategies of Armenia on women's advancement and gender equality, which enables an accurate calculation and use of potential human and financial resources. The Plan has taken into account Armenia's international commitments on the rights of women and gender equality issues, including those in the framework of the UN Convention on the Elimination of All Forms of Discrimination against Women, Beijing Declaration and Platform for Action, 2030 Sustainable Development Goals, the Universal Periodic Review and others.

Armenia has also included the implementation of the UNSCR 1325 provisions as a significant issue in the list of its 2020 – 2022 membership priorities to the Human Rights Council.

As a country fighting against mass atrocities, Armenia highly prioritizes the role of women and girls in the context of genocide prevention in its 1325 Plan.

1325 resolution "emphasizes the responsibility of all States to put an end to impunity and to prosecute those responsible for genocide, crimes against humanity, and war crimes including those relating to sexual and other violence against women and girls, and in this regard stresses the need to exclude these crimes, where feasible from amnesty provisions".
